

Harbor Island Bark Park

Rules & Regulations



The following rules and regulations shall govern the use of the Harbor Island Dog Park:

1. Any person bringing a dog(s) into this facility assumes legal responsibility, jointly and severally, with the owner of the dog(s), for any damage, disease, or injury to persons, other dog(s), or property caused by the dog(s). All persons using the facility, by entering it, agree to indemnify the Village of Mamaroneck and hold the Village of Mamaroneck harmless for any damage caused by the use of this facility.
2. Dog Park Hours: 8:00 a.m. to dusk. Maintenance may be performed prior to 8:00 a.m.
3. Any dog(s) in the park area at the time in which the maintenance crew arrives are to be leashed and removed from the area until the maintenance is completed. People and dog(s) may wait in the parking lot until it is clear to re-enter the park.
4. No person(s) may use the dog park unless their dog(s) are registered in advance with the Village of Mamaroneck and properly licensed as required by the Village Code.

6. No person may access the dog park if they are not accompanied by at least one dog.
7. Aggressive dogs are not permitted.
8. Dogs in heat are not permitted (spaying/neutering recommended).
9. No animals other than dogs may be brought into the fenced area.
10. All dog(s) must be leashed until safely inside the dog park enclosure and returned to a leash prior to exiting. Gates **MUST** be closed after entering and leaving the park.
11. Persons utilizing the dog park must not open the gate for other person(s) or dog(s) looking to enter the dog park.
12. No person may leave any dog(s) unattended. Persons utilizing the dog park shall keep the dog(s) in their line of sight and remain close enough to control the dog(s) if need be.

13. An adult must accompany anyone under 14 years of age. For the safety of children, we do not recommend bringing small children and infants into the dog park.
14. All dog(s) must wear properly fitted collars with license registration tags and identification tags while in the dog park. No pinch, choke, or spike collars allowed.
15. No person may bring more than TWO (2) dogs at any one time to the park.
16. Dog walkers, professional trainers, or any commercial enterprise are prohibited without the advance written approval of the Village Manager.
17. No dog(s) less than 4 months of age are allowed in the dog park.
18. Persons MUST clean-up after their dog(s) and dog waste must be bagged and disposed of in the trash receptacles at the park. Persons MUST fill in any holes caused or contributed to by their dog(s).
19. No smoking, vaping, alcoholic beverages, glass containers or food (people/animal) allowed in the dog park.
20. No wheeled recreational devices are allowed in the dog park.
21. The small dog park is designated for dogs 30lbs. or less.
22. A violation of any of these rules and regulations may result in the forfeiture of a dog park permit and/or issuance of a summons.
23. All other rules regarding Village Parks, as promulgated in the Village Code, are applicable within the dog park.

- **Dog License Fee (Spayed or Neutered): \$24.00**
- **Dog License Fee (Not Spayed or Neutered): \$30.00**
- **Dog Park Access Fee: \$26.00**
